ORDER

WHEREAS, in terms of Section 14(1) of the NCTE Act, 1993, Radha Govind Teachers Training College, Behind Ramgarh College, Ramgarh Cantt., Dist. Hazaribagh, Jharkhand-829122 has applied for grant of recognition for B.Ed. Course (Code No. APE00722) was received by Eastern Regional Committee of NCTE on 01.08.2001.

2. AND WHEREAS, the institution was granted recognition for conducting B.Ed. course vide Order No. ERC/7-71.4.15/ 2006/4961 dated 15.12.2006 with an intake of 100 (One hundred) by the ERC, NCTE, followed by revised order issued vide No. 32504 dated 30.05.2015 as per NCTE Regulations, 2014.

3. AND WHEREAS, as per decision of 244th ERC Meeting, recognition granted to B.Ed. course was withdrawn under section 17(1) of NCTE Act, 1993 from the next academic session vide ERC Order No. ER-244.17.2/APE00722/B.Ed./2017/54735 dated 18.10.2017.

4. AND WHEREAS, the institution preferred an appeal to NCTE HQs. and the Appellate Authority vide Order No. 89-741/E-43434/2017-Appeal/22nd Mtg.-2017/ 18th, 20th & 21st Dec., 2017/63174 dated 13.02.2018 remanded back the case to ERC with a direction to consider the appellant's reply dt. 31.10.2015 and the staff list enclosed thereto and take further action as per the NCTE Regulations, 2014. In the meanwhile, the order of withdrawal shall be kept in abeyance.

5. AND WHEREAS, the ERC in its 254th Meeting held on 16th - 17th April, 2018 reviewed the matter in accordance with the appeal order and observed that all required documents, as submitted by the institution to the Appellate Authority, have been received.

In view of the above, the Committee decided as under:

Recognition for B.Ed. Course is continued.

6. NOW THEREFORE, the recognition granted to B.Ed. Course issued vide order no. ERC/7-71.4.15/2006/4961 dated 15.12.2006 is hereby continued.

WHEREAS, in exercise of the powers conferred by sub-section(2) of Section 32 of the National Council for Teacher Education Act, 1993(73 of 1993), and in supersession of the National Council for Teacher Education [Recognition Norms and Procedure] Regulations, 2009, the National Council for Teacher Education has notified the Regulations, 2014 on 1.12.2014.

2. **AND WHEREAS**, the institution viz. **Radha Govind Teachers's Training (M.Ed.) The other contents of the restoration order dated 03.02.2021 shall remain unchanged.


